

常見問題

問	：	培僑書院家長教師會的全名是甚麼？
答	：	全名是『培僑書院家長教師會有限公司』(下稱“家教會”)。
問	：	培僑書院家長教師會有限公司是否培僑書院屬下機構？
答	：	不是。家教會是一個獨立法定機構。
問	：	培僑書院家長教師會有限公司是否根據社團條例註冊的組織？
答	：	不是，家教會是根據香港法例第 32 章《公司條例》以無股本的擔保有限公司形式成立。
問	：	培僑書院家長教師會有限公司的會員責任是否有限？
答	：	根據家教會的組織章程大綱，會員的法律責任是有限的。
問	：	培僑書院家長教師會有限公司的宗旨是甚麼？
答	：	家教會的宗旨詳列於其組織章程大綱，亦可參考中文版的會章概要。
問	：	培僑書院家長教師會有限公司如何運作？
答	：	家教會的最高權力機構是會員大會，而日常會務則由家長會員和校方當然會員所組成的董事局處理。
問	：	培僑書院家長教師會有限公司的董事局是如何組成的？
答	：	根據家教會的章程，董事局由 8 至 16 位家長會員和 4 至 8 位校方當然會員組成，前者由家長會員選出，後者由校方委任。在 2008 年 2 月 2 日舉行的家教會特別會員大會中，第一屆董事選舉順利選出和委任 12 位家長會員董事和 6 位當然會員董事。
問	：	培僑書院家長教師會有限公司是否可以參與法團校董會的決策？
答	：	不可以。但家教會必須先取得培僑書院法團校董會的確認，並根據香港法例第 279 章《教育條例》安排公平而公開透明的家長校董選舉，該被選出的家長校董則於法團校董會擁有發言權。
問	：	培僑書院家長教師會有限公司的會址在那裡？
答	：	家教會的會址定於香港新界沙田大圍下城門道培僑書院。辦事處位於培僑書院小學部一樓的家長資源室。
問	：	誰可成為培僑書院家長教師會有限公司的會員？
答	：	會員分三類： 一. 所有培僑書院現有學生家長均可成為家長會員。 二. 培僑書院的校長、副校長和所有教師均可成為當然會員。

		三. 對家教會有貢獻的人可被委任為有發言但無投票權的榮譽會員。
問	:	培僑書院家長教師會有限公司的會員是否需要繳交會費？
答	:	當然會員和榮譽會員不用繳費。家長會員須依時繳交不可退回的年費以保持會籍，首次會費為港幣一百元(HK\$100)，將來的年費由其時的董事局酌情決定。
問	:	培僑書院家長教師會有限公司的會員會籍如何訂定？
答	:	家教會的會員會籍將隨學年而開始及終結(即每年的9月1日至翌年的8月31日)，唯第一屆的會籍始於入會當天而終於該學年的最後一天(即2008年8月31日)。
問	:	培僑書院家長教師會有限公司的會員如何成為家教會董事？
答	:	根據家教會的章程，家長會員和當然會員均可遵照既定的選舉和委任程序成為家教會董事局成員。
問	:	培僑書院家長教師會有限公司的董事任期如何訂定？
答	:	根據家教會的章程，董事的任期始於被委任當天而終於下屆週年會員大會結束時。
問	:	在培僑書院家長教師會有限公司的會員大會上，誰人有投票權？
答	:	所有家長會員和當然會員均於會員大會中擁有投票權。
問	:	培僑書院家長教師會有限公司的具體工作是甚麼？
答	:	家教會的具體工作由董事局制定，董事局主席將於每年的週年大會上匯報過去一年度之工作。
問	:	誰是培僑書院家長教師會有限公司的現任董事？
答	:	經大會委任的當然會員董事是張聖君副校長、曹建偉、謝秉善、黃騰達、吳迎旋和姚甄茵老師。經選舉產生的家長會員董事是陳家傑、陳淑儀、鄭樹森、張主文、秦順麟、鍾偉健、馮藹榮、何鍵和、梁淑霞、梁沛然、盧雅然和馬家強。

FAQ

Q	:	What is the full name of the Parent-Teacher Association of Pui Kiu College?
A	:	It is Pui Kiu College Parent-Teacher Association Limited (hereinafter referred to as "PTA").
Q	:	Is Pui Kiu College Parent-Teacher Association Limited a subsidiary of Pui Kiu College?
A	:	No. PTA is an independent legal entity.

Q	:	Is Pui Kiu College Parent-Teacher Association Limited an organization registered under the Societies Ordinance?
A	:	No. PTA is a company limited by guarantee and not having a share capital incorporated pursuant to the Companies Ordinance (Chapter 32, Laws of Hong Kong).
Q	:	Is liability of the members of this PTA limited?
A	:	According to the Memorandum of Association of Pui Kiu College Parent-Teacher Association Limited, the liability of members is limited.
Q	:	How was Pui Kiu College Parent-Teacher Association Limited incorporated?
A	:	The objects of PTA are listed in the <u>Memorandum of Association</u> Reference may also be made to the <u>Chinese excerpt of PTA's constitution</u> .
Q	:	How is Pui Kiu College Parent-Teacher Association Limited operated?
A	:	PTA in its general meeting may exercise all powers vested in it, while its board of directors consisting of parent members and ex officio members will be responsible for daily operation.
Q	:	How is the board of Pui Kiu College Parent-Teacher Association Limited constituted?
A	:	According to the constitution of PTA, the board of directors will be consisting of 8 to 16 parent members and 4 to 8 ex officio members, the former from election and the later by appointment of the College. At the Extraordinary General Meeting of PTA held on 2 nd February 2008, 12 directors from parent members and 6 directors from ex officio members were returned by the 1 st directors' election and appointed respectively.
Q	:	Can this PTA participate in the policy making process of incorporated management committee of Pui Kiu College (hereinafter referred to as "the IMC")?
A	:	No. PTA will first procure recognition by the IMC and then arrange according to Education Ordinance (Chapter 279, Laws of Hong Kong) the election of the parent manager in a fair and transparent manner. The elected parent manager will have the right to speak in the IMC.
Q	:	Where is the registered office of this PTA?
A	:	The registered office of PTA is at Pui Kiu College, Lower Shing Mun Road, Tai Wai, Shatin, New Territories, Hong Kong. The office of PTA is located at the Parent Resources Room on 1 st Floor of the Primary Section of Pui Kiu College.
Q	:	Who may be a member of PTA?
A	:	There are three types of membership: <ol style="list-style-type: none"> 1. All parents/guardians of current students of Pui Kiu College may join as <u>parent members</u>. 2. The Principal, Assistant Principals and teachers of Pui Kiu College may join as

		<u>ex officio members</u> . 3. People with contribution to PTA may be appointed as <u>honorary members</u> with the right to speak.
Q	:	Are PTA members required to pay membership fees?
A	:	Ex officio members and Honorary members are not required to pay any membership fees. Parent members must pay the non-refundable annual membership fees in time to maintain the membership. The first membership fee is Hong Kong Dollars One Hundred (HK\$100) and fees for the future years will be determined by the directors for the time being as they think fit.
Q	:	What is the term of membership in PTA?
A	:	PTA membership will begin and end according to academic year (namely, from 1 st September to 31 st August in the next year), while the first term of membership shall begin on the date of membership admission and end with the current academic year (namely, 31 st August 2008).
Q	:	How can a member of PTA become a director?
A	:	According to the constitution of PTA, parent members and ex officio members may be elected and appointed respectively as directors of PTA according to the prescribed procedures.
Q	:	What is the term of PTA directorship?
A	:	According to the constitution of PTA, directorship will commence with its appointment and ends with the closing of the next Annual General Meeting of PTA.
Q	:	Who may vote in a general meeting of PTA?
A	:	All parent members and ex officio members may vote in any general meeting of members.
Q	:	What are the specific tasks of PTA?
A	:	Specific tasks of PTA will be decided by the board of directors. The Chairperson of the PTA's board of directors shall present a report of PTA work in the past year at the Annual General Meeting.
Q	:	Who are the present directors of PTA?
A	:	Ex officio members of the board of directors appointed by general meeting are Cheung Sing Kwen (Deputy Principal of Pui Kiu College), Cao Jian Wei Moni, Tse Pin Sin, Wong Tang Tat Tommy, Wu Ying Shuen Heidi and Yiu Yan Yan (teachers). Parent members of the board of directors returned through election are Chan Ka Kit, Chan Suk Yee, Cheng Shu Sum Summe, Cheung Chu Man Raymond, Chun Shun Lun Kenneth, Chung Wai Kin, Fung Hoi Wing, Ho Kin Wo, Leung Pui Yin Sandra, Leung Suk Ha Victoria, Lo Ngar Yin and Mah Ka Keung.
